ARA Communiqué 3: Request for Meeting

The Amahlathi Residence Association (ARA) represent numerous households, businesses and farmers in the greater Amahlathi area. On 26 June 2019 the ARA called a meeting with a broad-base of stakeholders (See attached attendance register as **Annexure A**), which include businesses and various other formal and informal community organisations with interest in Amahlathi area, to specifically discuss the financial state of the municipality as well as the recent Notice issued by ESKOM placing the Amahlathi Local Municipality (ALM) on terms for non-payment of electricity.

The participants of the meeting mandated the ARA to communicate on behalf of their respective constituencies and specifically request ALM for the following:

1. That ALM in coordination with the ARA arrange an urgent engagement with the new MEC of the Department of Co-operative Governance and Traditional Affairs (COGTA), with representatives from the ARA, Business Community, as well as the various community organisations represented.
2. That ALM furnish the ARA with a letter committing to pay ESKOM in relation to the notice issued by ESKOM, to avoid the load shedding, as well as any other correspondence or agreements directly with ESKOM in the same regard, which includes acknowledgements by ESKOM.
3. That ALM furnish the ARA with a letter that ALM staff will be paid going forward, with a commitment by when service delivery will be reinstated per department, since we are in particular concerned with the cleaning of the town, as well as the Traffic Department, becoming functional again.

In terms of the time frames to address the above, we would appreciate a written response by not later than **5 July 2019**. 



